

## Notification to FSANZ under section 13A of the Agvet Code

- 1. Pursuant to section 13A of the Agricultural and Veterinary Chemicals Code (the Agvet Code set out in a Schedule to the *Agricultural and Veterinary Chemicals Code Act 1994*), the APVMA notifies FSANZ that applications have been made in relation to chemical products and, in the APVMA's opinion it is likely that, if the applications are granted, variations to Standard 1.4.2 (Maximum Residue Limits) would be required.
